**BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**A Resolution Awarding a Contract for the Purchase of Filtration Spheres  
in the amount of \$31,336 from Vendor Akron Porcelain & Plastics Co  
Funded From Account 01-721-004X**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") is in need of filtration spheres; and

**WHEREAS**, the Authority has requested and received a price quote for the purchase of filtration spheres from The Akron Porcelain & Plastics Co. in the amount of \$31,336; and

**WHEREAS**, the Authority, having a Qualified Purchasing Agent and making use of the State Bidding Law, the proposed purchase is exempt from public bidding requirements of the Local Public Contracts Law; and

**WHEREAS**, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds exist within Capital Budget Account 01-721-004X to fund the purchase of filtration spheres.

**NOW, THEREFORE, BE IT RESOLVED** this 30th day of September, 2021, by the Brick Township Municipal Utilities Authority as follows:

1. The contract for the purchase of the aforesaid filtration spheres is hereby awarded to Akron Porcelain & Plastics Co. in the amount of \$31,336.
2. The Chairman and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution subsequent to the execution of same by Akron Porcelain & Plastics Co..
