A Resolution for Award of Bid for Pipe and Appurtenance Materials

WHEREAS, the Brick Township Municipal Utilities Authority (“Brick Utilities”), pursuant to Local Public Contract Law N.J.S.A. 40A:11-1 et seq. duly advertised for bid for Pipe and Appurtenance Materials; and

WHEREAS, five (5) bids were received pursuant to the advertisement and publicly opened on October 20, 2021 at 10:00 a.m.; and

WHEREAS, said bids and a recommendation from Qualified Purchasing Agent Robert W. Bowers have been reviewed by the Brick Utilities and bid packages having been submitted for the review of Ben A. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to Brick Utilities; and

WHEREAS, bids were requested for a total of 82 items; and

WHEREAS, Core and Main, P.P. did submit a responsive and responsible bid and is low bidder for Item Nos. 2, 3, 7-11, 13 and 18; and

WHEREAS, Cutter Drill & Machine Inc. did submit a responsive and responsible bid and is low bidder for Item Nos. 12, 22, 24, 26, 27, 29-32, 35, 39, 43, 44, 48, 51, 53, 60-63, 65 and 82; and

WHEREAS, Ferguson Enterprises L.L.C. did submit a responsive and responsible bid and is low bidder for Item Nos. 1, 4-6, 14-17, 19-21, 23, 25, 28, 36-37, 40-42, 45-47, 49, 52, 54-59, 64, 66-68, 70-74, 76-78, 80-81; and

WHEREAS, Raritan Group Inc. did submit a responsive and responsible bid and is low bidder for Item Nos. 33, 34, 38, 50, 69, 75 and 79; and

WHEREAS, the term of the Contract with Core and Main, L.P.; Cutter Drill & Machine Inc.; Ferguson Enterprises LLC; and Raritan Group Inc. shall be for one year from the date of award; and

WHEREAS, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds do exist for payment of these contracts.


NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

1. That the Contract for the Pipe and Appurtenance Item Nos. 2, 3, 7-11, 13 and 18; for a total bid amount of \$5,645.50 is awarded to Core and Main, L.P. in accordance with the attached Bid Award Sheet; and
2. That the Contract for Pipe and Appurtenance Item Nos. 12, 22, 24, 26, 27, 29-32, 35, 39, 43, 44, 48, 51, 53, 60-63, 65 and 82 for a total bid amount of \$12,896.38 is awarded to Cutter Drill & Machine Inc. in accordance with the attached Bid Award Sheet; and
3. That the Contract for Pipe and Appurtenance Item Nos. 1, 4-6, 14-17, 19-21, 23, 25, 28, 36-37, 40-42, 45-47, 49, 52, 54-59, 64, 66-68, 70-74, 76-78 and 80-81 for a total bid amount of \$41,909.50 is awarded to Ferguson Enterprises, L.L.C. in accordance with the attached Bid Award Sheet; and
4. That the Contract for Pipe and Appurtenance Item Nos. 33, 34, 38, 50, 69, 75 and 79 for a total bid amount of \$1,403.79 is awarded to Raritan Group Inc. in accordance with the attached Bid Award Sheet; and
5. The Qualified Purchasing Agent be and is hereby authorized to notify all bidders of the award of these contracts.
6. The Authority's Chairman and Secretary are hereby authorized to execute contracts and any necessary documents in furtherance of the contract awards to the four (4) low bidders herein.


