**A Resolution for Rejecting all Bids for the Truck Wash System;  
Brick Utilities' Contract No. 919003X**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the Truck Wash System, Contract No. 919003X; and

**WHEREAS**, bids for the Contract have been solicited by the Authority in conformance with the provisions of the New Jersey Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, a single bid was received November 10, 2021 in response to the bid solicitation, as follows:

1. ESD Waste2Water, Inc. \$100,000.00; and

**WHEREAS**, N.J.S.A. 40A:11-13.2 provides the basis upon which a contracting unit may reject all bids, including when the lowest bid substantially exceeds the cost estimates for the goods/services; and

**WHEREAS**, the bid substantially exceeds the cost estimate for the project; and

**NOW, THEREFORE, BE IT RESOLVED** this 23<sup>rd</sup> day of November, 2021, by the Brick Township Municipal Utilities Authority as follows:

1. The Authority rejects the bid submitted for the Truck Wash System.
2. The Commissioners authorize staff to review the bid documentation and determine in their discretion whether to immediately re-bid and/or that the specifications should be substantially revised.
3. The Authority authorizes and directs the Chairman, Executive Director, and Secretary to execute any and all necessary documents in order to implement the intent of this Resolution.

**WHEREAS**, no bids were received November 10, 2021 in response to the bid solicitation; and


**WHEREAS**, the contract shall be re-bid; and
