A Resolution Authorizing the Purchase of an Annual Service Contract for Laboratory Equipment in the Amount of \$30,158.64 From Vendor Agilent Technologies Inc Funded from Account 203-8202

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") is in the need of an Annual Service Contract for Laboratory Equipment; and

WHEREAS, the Authority has requested and received price quotes from multiple vendors for the subject service contract and Agilent Technologies Inc. was the lowest responsive quote; and

WHEREAS, the Authority, having a Qualified Purchasing Agent and making use of the State Bidding Law, the proposed purchase is exempt from public bidding requirements of the Local Public Contracts Law; and

WHEREAS, the Authority received a price quote for the purchase of an Annual Service Contract for Laboratory Equipment from Agilent Technologies Inc in the amount of \$30,158.64; and


