A Resolution Awarding Bid for Water Treatment Chemicals

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the supply of water treatment chemicals for Fiscal Year 2022/2023 [April 1, 2022 to March 31, 2023]; and

WHEREAS, bids have been solicited by the Authority for the project in conformance with the provisions of the New Jersey Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11 <u>et seq.</u>, and

WHEREAS, bids were received pursuant to the advertisement and publicly opened on February 9, 2022 at 10:00 a.m.; and

WHEREAS, the bids have been carefully reviewed by Robert Bowers, Q.P.A., the Authority Solicitor, Ben A. Montenegro, and a recommendation has been made to the Commissioners by Director Clifford as to the lowest responsible bidder for each of the chemicals, as follows:

- 1. The contracts for the chemicals be and hereby are awarded as hereinabove set forth, subject to all conditions outlined in the Notice to Bidders and Specifications.
- 2. The Chairman and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution.
- 3. The Executive Director be and hereby is authorized to return the bid bonds and other security received from the unsuccessful bidders within three (3) days after execution of the contracts, and to notify all bidders of the award of these contracts.
