A RESOLUTION AUTHORIZING THE PURCHASE OF THREE DELL POWEREDGE R550 HOST SERVERS INCLUDING INSTALLATION, CONFIGURATION AND THREE YEAR SUPPORT CONTRACT; IN THE AMOUNT OF \$59,256.60; VENDOR – CDW GOVERNMENT, INC. THROUGH STATE CONTRACT #ESCNJ18/19-03; CAPITAL ACCOUNT NO. 01-910-004X

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has implemented a virtualized data center which incorporates three Dell host servers; and

WHEREAS, the Authority's current virtual host servers are eight years old and have inadequate memory capacity; and

WHEREAS, the current host servers are unable to be upgraded to the latest VMWare software version; and

WHEREAS, new host servers need to be purchased to avoid hardware failure and to secure our host servers to the latest VMWare version; and

WHEREAS, CDW Government, Inc. (hereinafter referred to as CDW-G) a State Contract vendor has provided a price quote of \$59,256.60 for purchase of three Dell PowerEdge R550 Servers which include installation, configuration, and a three year support contract; and

WHEREAS, the new Dell R550 Servers will provide twice the memory capacity (with an option to triple the memory), more than double the processor speed, and be compatible with the latest VMWare version; and

WHEREAS, as a result of utilizing the State Contract vendor the proposed purchase is exempt from public bidding requirements of the Local Public Contracts Law; and

WHEREAS, the Authority's Director of Compliance and Technology recommends purchase of said support appliances; and

WHEREAS, Brick Utilities Chief Financial Officer, John Clifford, has advised that sufficient funds for the payment of \$59,256.60 exist in the Authority's Capital Project 01-910-004X.

NOW, THEREFORE, BE IT RESOLVED THIS 28th DAY OF APRIL, 2022, BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY as follows:

- 1. The Authority hereby authorizes a contract to CDW-G for the purchase of three Dell PowerEdge R550 Servers which include installation, configuration, and a three year support contract in the amount of 59,256.60; and
- 2. Said amount of \$59,256.60 shall be funded from Capital Project Number 01-910-004X; and
- 3. Brick Utilities' Chairman and Secretary are hereby authorized to execute an Agreement for these services subsequent to the execution of said Agreement by CDW-G; and
