**Resolution Authorizing the Award of a Contract in the amount of \$37,700 for
Redevelopment of Wells 13 and 14 to Vendor Municipal Maintenance Co. from Account
01-720-004X**

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") is in need of redeveloping Wells 13 & 14 and has solicited bids therefore; and

WHEREAS, bids for said redevelopment have been solicited by the Authority in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et. seq.; and

WHEREAS, three (3) bids were received in response to the bid solicitation as follows:

WHEREAS, the proposal submitted by Municipal Maintenance, Co. has been reviewed by Authority staff and has been found to be acceptable as to form and content and is in compliance with the needs of the Authority; and

WHEREAS, the Authority's Director of Water Quality is recommending the award of this contract to Municipal Maintenance Co., the lowest bidder in the amount of \$37,700.00.

WHEREAS, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds exist within Capital Budget Account 01-720-004X to fund the purchase of the aforesaid services.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF BRICK UTILITIES as follows:

1. The above referenced Contract is hereby awarded to the low bidder, Municipal Maintenance, Co, in the amount of \$37,700.00 subject to all conditions outlined in the Notice to Bidders, Specifications and Contract Documents; and
2. The Authority Chair and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution subsequent to the execution of the contract by Municipal Maintenance Co.
3. Said amount of \$37,700 shall be funded from Capital Project No. 01-720--004X

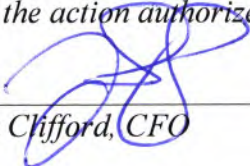
