WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the purchase of Two (2) 2023 Model or Newer 6-8 Yard Dump Trucks; and

WHEREAS, bids for the contract have been solicited by the Authority in conformance with the provisions of the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, three (3) bids were received on July 19, 2022 at 10:00 a.m. in response to the bid solicitation, as follows:




