WHEREAS, three (3) bids were received pursuant to the advertisement and publicly opened on March 9, 2023 at 10:00 a.m.; and

WHEREAS, said bids and a recommendation from Qualified Purchasing Agent Robert W. Bowers have been reviewed by the Brick Utilities and bid packages having been submitted for the review of Ben A. Montenegro of Montenegro, Thompson, Montenegro & Genz, General Counsel to Brick Utilities; and

WHEREAS, bids were requested for a total of 31 items; and

WHEREAS, Core and Main, L.P. did submit a responsive and responsible bid and is low bidder for Item Nos. 1, 2, 4, 5, 9, 11-14, 16-22 and 31; and

WHEREAS, Cutter Drill & Machine Inc. did submit a responsive and responsible bid and is low bidder for Item Nos. 6, 23-25, 27, 29 and 30; and

WHEREAS, Atlantic Plumbing Supply Corp. did submit a responsive and responsible bid and is low bidder for Item Nos. 3, 7, 8, 10, 26 and 28; and

WHEREAS, no bids were received for Item Number 15; and

WHEREAS, the term of the Contract with Core and Main, L.P.; Cutter Drill & Machine Inc.; and Atlantic Plumbing Supply Corp. shall be for one year from the date of award; and

WHEREAS, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds do exist for payment of these contracts.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Brick Township Municipal Utilities Authority as follows:

- 3. That the Contract for Pipe and Appurtenance Item Nos. 3, 7, 8, 10, 26 and 28 for a total bid amount of \$6,670.00 is awarded to Atlantic Plumbing Supply Corp. in accordance with the attached Bid Award Sheet; and
- 4. The Qualified Purchasing Agent be and is hereby authorized to notify all bidders of the award of these contracts.
- 5. The Authority's Chairman and Secretary are hereby authorized to execute contracts and any necessary documents in furtherance of the contract awards to the three (3) low bidders herein.
