**A Resolution Authorizing the Purchase of a Thermo-Fischer Ion Chromatograph from Vendor Thermo-Fischer in the Amount of \$38,911.58 Funded From Account 01-724-002X**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") is in need of and seeks to purchase a Thermo-Fischer Ion Chromatograph; and

**WHEREAS**, Thermo-Fischer is the sole source vendor for the Thermo-Fischer Ion Chromatograph; and

**WHEREAS**, the Authority has requested and received a price quote for the purchase of a Thermo-Fischer Ion Chromatograph from Thermo-Fischer in the amount of \$38,911.58; and

**WHEREAS**, The Authority as part of this transaction will trade in its Dionex Ion Chromatograph to Thermo-Fischer; and

**WHEREAS**, Director Joseph Maggio recommends the purchase of a Thermo-Fischer Ion Chromatograph; and


