## A Resolution Awarding Bid for Water Treatment Chemical - Zinc Orthophosphate

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") has solicited bids for the supply of water treatment chemical – Zinc Orthophosphate for six (6) months [10/1/23-3/31/24]; and

WHEREAS, bids have been solicited by the Authority for the project in conformance with the provisions of the New Jersey Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11 et seq., and

WHEREAS, two (2) bids were received pursuant to the advertisement and publicly opened on August 2, 2023 at 10:00 a.m.; and

WHEREAS, the bids have been carefully reviewed by Robert Bowers, Q.P.A., the Authority Solicitor, Ben A. Montenegro, and a recommendation has been made to the Commissioners by Director of Water Quality Joseph Maggio, P.E., as to the lowest responsible bidder, as follows:

WHEREAS, the bid documentation submitted by the lowest responsible bidder for Zinc Orthophosphate has been reviewed by Director Maggio, Robert Bowers, QPA, and the Authority Solicitor and has been found acceptable as to form and content, and is in compliance with the bid specifications; and

**WHEREAS,** any 2023/2024 budget overrun for chemicals will be accounted for from within other 2023/2024 operating accounts;

**NOW, THEREFORE, BE IT RESOLVED** this 29<sup>th</sup> day of August, 2023, by the Brick Township Municipal Utilities Authority as follows:

1. The contract for the chemical – Zinc Orthophosphate (6 month) be and hereby are awarded as hereinabove set forth, subject to all conditions outlined in the Notice to Bidders and Specifications.

2. The Chairman and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution.

3. The Executive Director be and hereby is authorized to return the bid bonds and other security received from the unsuccessful bidders within three (3) days after execution of the contracts, and to notify all bidders of the award of these contracts.
