WHEREAS, said vendor will provide one (1) 2024 Ford F450 Regular Cab 4X2 Utility Body with factory and post market options at a total price of \$62,129.00; and

WHEREAS, as a result of utilizing the New Jersey State Contract vendor the proposed purchase is exempt from public bidding requirements of the Local Public Contracts Law; and

WHEREAS, Brick Utilities Chief Financial Officer, John Clifford, has advised that sufficient funds for the payment of \$62,129.00 is accounted for in the Authority's Capital Budget within the item listed as Capital Project No. 824004X.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY as follows:

- 2. The Authority authorizes and directs the Chairman and Secretary to execute any and all necessary documents in order to implement the intent of this Resolution subsequent to the execution of same by Winner Ford, 250 Haddonfield-Berlin Rd, Cherry Hill, New Jersey 08034; and
- 3. Said amount of \$62,129.00 shall be funded from Capital Project No. 824004X; and
