

**RESOLUTION NO. 77-23**

**BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**November 30, 2023**

**A Resolution Authorizing the Contracting of Services from Longo Electrical Mechanical Inc. for the Planned Maintenance of Raw Water Pump #4 in the Amount of \$20,730 Funded from Account 718-007**

**WHEREAS**, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") seeks to contract services for the planned maintenance of Raw Water Pump #4; and

**WHEREAS**, the Authority requested prices from multiple vendors for the planned maintenance of Raw Water Pump #4 and Longo Electrical Mechanical Inc. was the lowest responsive bidder; and

**WHEREAS**, Director Maggio of the Authority is recommending the award of this contract to Longo Electrical Mechanical Inc, the lowest responsive bidder in the amount of \$20,730; and

**WHEREAS**, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds exist within Capital Budget Account 718-007 to contract services for the planned maintenance of Raw Water Pump #4.

**NOW, THEREFORE, BE IT RESOLVED** this 30th day of November, 2023, by the Brick Township Municipal Utilities Authority as follows:

1. A contract for planned maintenance of raw water pump number #4 is hereby awarded to the low bidder Longo Electrical Mechanical Inc. in the amount of \$20,730.
2. The Chairman and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution subsequent to the execution of same by Longo Electrical Mechanical Inc.
