### A Resolution Amending Resolution No. 02-23 to Increase the Second- and Third-Year Microsoft Office 365 Annual Subscription From \$28,674.10 per year to \$29,359.10 Funded from Operating Account 502-8201

WHEREAS, the Brick Township Municipal Utilities Authority (the "Authority") did enter into a contract for a three-year subscription of Microsoft Office 365 in the amount of \$86,022.30 from vendor CDW Government, Inc. through State Contract #20-TELE-01511/T3121; and

WHEREAS, said contract was authorized by Resolution No. 02-23; and

WHEREAS, since execution of the contract, the Authority's IT Supervisor has determined that new Visio licensing software is needed as the Authority is unable to use existing Visio licenses with this subscription; and

WHEREAS, the cost for Visio licensing is an additional \$685.00 per year, which increases the annual subscription costs for years two and three under the contract to \$29,359.10;

WHEREAS, The Authority's Director of Compliance and Technology, Gary Vaccaro, has reviewed this amendment and is recommending that it be approved.

WHEREAS, the Authority's Chief Financial Officer, John Clifford, has advised the Authority that sufficient funds for the increased annual payment of \$29,359.10 does exist within Operating Account Number 01-502-8201

### NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY as follows:

1. Resolution No. 02-23 is hereby amended and the contract price between the Authority and CDW Government, Inc. is amended is adjusted to account for the required Visio licensing software; and

2. The annual subscription costs for years two and three under the contract are increased to \$29,359.10; and
