**A Resolution for Approving and Authorizing the Award of a Contract to A.C. Schultes Inc. in the amount of \$612,220.00 for the Redevelopment of Well No. 15A; Brick Utilities' Contract No. 724009X**

**WHEREAS**, on December 11, 2023, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., advertised for bids for the Redevelopment of Well No. 15A, Contract No. 724009X; and

**WHEREAS**, two (2) bids ranging in price from a low of \$612,220.00 to a high of to \$1,711,220.00 were received pursuant to the advertisement and publicly opened on January 18, 2024 at 2:00 P.M.; and

**WHEREAS**, the submitted bids have been reviewed by the Authority's Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E., and the Authority's Counsel, Ben A. Montenegro, Esq.; and

**WHEREAS**, the Authority's Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E., noted no irregularities with the bid received from A.C. Schultes Inc. as part his review of all of the bids; and

**WHEREAS**, the Authority's Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E., is recommending the award of this Contract to A.C. Schultes Inc. the lowest bidder, in the amount of \$612,220.00; and


**WHEREAS**, Brick Utilities' Chief Financial Officer, John Clifford, has advised Brick Utilities that sufficient funds for the payment of \$612,220.00 do exist for Capital Project No. 724009X in the Authority's Fiscal Year 2023/2024 Capital Budget

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY** as follows:

1. The Redevelopment of Well No. 15A, Contract No. 724009X, is hereby awarded to the low bidder, A.C. Schultes Inc., in the amount of \$612,220.00 subject to all conditions outlined in the Notice to Bidders, Specifications and Contract; and
2. The Authority's Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E., has recommended to the Authority that A.C. Schultes Inc. as the low bidder be awarded the Contract; and
3. The Authority's Deputy Executive Director and Director of Engineering/Operations, Stephen T. Specht, P.E., is authorized to return the bid bonds and other security received from the unsuccessful bidders within three (3) days after execution of the contract and to notify all bidders of the award of the contract; and
4. The Authority's Chairman and Secretary are hereby authorized to execute a contract with A.C. Schultes Inc., 664 South Evergreen Avenue, Woodbury Heights, NJ 08097 for this project, subsequent to the execution of said contract by an authorized representative of A.C. Schultes Inc.; and
5. Said amount of \$612,220.00 shall be funded from Capital Project No. 724009X for the payment of the obligation provided for herein; and
