The offices of Fallon & Company, LLP, shall maintain at all times during the term of this employment adequate Professional Liability Insurance including, but not limited to, an Errors and Omissions Policy in an amount in accordance with the RFQ for professionals/consultants, and which agreement is made a part thereof.
- 4. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law.
- 5. The Executive Director shall cause notice of award of said appointment to be published one time in the designated official newspaper of the Authority.
