BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

A Resolution Authorizing the Purchase of an Annual Service Contract for Laboratory Equipment in the Amount of \$30,685 From Vendor Agilent Technologies Inc Funded from Account 203-8202

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the “Authority”) is in the need of an Annual Service Contract for Laboratory Equipment; and

WHEREAS, the Authority has requested and received price quotes from multiple vendors for the subject service contract and Agilent Technologies Inc. was the lowest responsive quote; and

WHEREAS, the Authority, having a Qualified Purchasing Agent and making use of the State Bidding Law, the proposed purchase is exempt from public bidding requirements of the Local Public Contracts Law; and

WHEREAS, the Authority received a price quote for the purchase of an Annual Service Contract for Laboratory Equipment from Agilent Technologies Inc in the amount of \$30,685; and

WHEREAS, the Authority has determined that the total cost of the annual service contract is reasonable; and

WHEREAS, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds exist within Operating Budget Account 203-8202 to fund the purchase of the aforesaid service contract.

NOW, THEREFORE, BE IT RESOLVED this 27th day of February, 2024, by the Brick Township Municipal Utilities Authority as follows:

1. The contract for the purchase of the annual service contract is hereby awarded to Agilent Technologies Inc in the amount of \$30,685
2. The procurement of the aforesaid annual service contract as described above from Agilent Technologies Inc is hereby authorized.
3. The Chairman and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution subsequent to the execution of same by Agilent Technologies Inc.
