WHEREAS, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, Sourcewell (formerly known as National Joint Powers Alliance or NJPA) has offered voluntary participation in a Cooperative Pricing System for the procurement of goods and services; and

WHEREAS, the Brick Township Municipal Utilities Authority's Board of Commissioners (hereinafter referred to as the "Authority") at the June 29, 2017 Public Meeting authorized the Brick Township Municipal Utilities Authority's participation in the National Joint Powers Alliance (now known as Sourcewell) Cooperative Pricing System; and

WHEREAS, the Authority is seeking to purchase a 2025 Freightliner 114SD Chassis with the Vactor Jet Vac Equipment; and

WHEREAS, the services of the vendor, GranTurk Equipment Co., Inc. can be procured through the Sourcewell Cooperative Pricing System for a total price of \$518,619.82; and

WHEREAS, the Authority's Chief Financial Officer, John Clifford, has advised the Authority that sufficient funds for the payment of \$518,619.82 do exist in Capital Project No. 01-825-001X.

NOW, THEREFORE, BE IT RESOLVED this 27th day of March, 2024 by the Brick Township Municipal Utilities Authority as follows:

- 1. The purchase of a 2025 Freightliner 114SD Chassis with the Vactor Jet Vac Equipment through Sourcewell Cooperative Pricing System vendor, GranTurk Equipment Co., Inc., in the total amount of \$518,619.82 is hereby authorized.
- The Authority authorizes and directs the Chairman and Secretary to execute any and all necessary documents in order to implement the intent of this Resolution subsequent to the execution of same by GranTurk Equipment Co., Inc., One Schuykill Parkway, Building B, Bridgeport, Pennsylvania 19405-1069.
- 4. Said amount of \$518,619.82 shall be taken from Capital Project No. 01-825-001X for the payment of the obligation provided for herein.
