A Resolution Awarding the Contract for the Purchase of One (1) 2023 Ford F-250 XL 4WD Utility Body in the Total Amount of \$63,534.00 from Nielsen Ford through State of New Jersey Contract #23-FLEET-34922; Brick Utilities' Capital Project No. 01-725-003X

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter referred to as the "Authority") is in need of a of one (1) 2023 Ford F-250 XL 4WD Utility Body; and

WHEREAS, Authority personnel had contacted the State of New Jersey Contract vendor, Nielsen Ford, to provide an estimate for the purchase of one (1) 2023 Ford F-250 XL 4WD Utility Body, with available options, as per State of New Jersey Contract #23-FLEET-34922; and

WHEREAS, said vendor will provide items in strict accordance with State of New Jersey Contract pricing; and

WHEREAS, said vendor will provide one (1) 2023 Ford F-250 XL 4WD Utility Body with factory and post market options at a total price of \$63,534.00; and

WHEREAS, as a result of utilizing the State of New Jersey Contract vendor, the proposed purchase is exempt from public bidding requirements of the Local Public Contracts Law; and

WHEREAS, Brick Utilities Chief Financial Officer, John Clifford, has advised that sufficient funds for the payment of \$63,534.00 is accounted for in the Authority's Capital Budget within the items listed as Capital Project No. 01-725-003X.

NOW, THEREFORE, BE IT RESOLVED this 30th day of May, 2024, by the Brick Township Municipal Utilities Authority as follows:

1. The contract for this purchase be and is hereby awarded to Nielsen Ford, in the total amount of \$63,534.00 for one (1) 2023 Ford F-250 XL 4WD Utility Body as per State of New Jersey Contract #23-FLEET-34922.
2. The Authority authorizes and directs the Chairman and Secretary to execute any and all necessary documents in order to implement the intent of this Resolution subsequent to the execution of same by Nielsen Ford, 170 Ridgedale Avenue, Morristown, New Jersey 07960.
3. Said total amount of \$63,534.00 shall be funded from Capital Project Nos. 01-725-003X for the payment of the obligation provide for herein; and
