# A Resolution Awarding Bid for Granulated Activated Carbon Maintenance

WHEREAS, the Brick Township Municipal Utilities Authority (hereinafter the "Authority") has solicited bids for the Granulated Activated Carbon (GAC) maintenance project at the William Miller Jr. Water Treatment Plant; and

**WHEREAS**, bids have been solicited by the Authority for the project in conformance with the provisions of the New Jersey Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1 et seq.; and

WHEREAS, one (1) bid was received pursuant to the advertisement and publicly opened on May 30, 2024 at 10:30 a.m.; and

WHEREAS, said bid package and a recommendation from Robert Bowers, Q.P.A. have been reviewed by the Authority and Ben A. Montenegro, Esq. of Montenegro, Thompson, Montenegro & Genz, General Counsel to the Authority; and

WHEREAS, it has been determined that Calgon Carbon Corporation is the sole responsible and responsive bidder for the project and has bid on the following items:

WHEREAS, the Authority's Chief Financial Officer, John Clifford, has advised the Authority that sufficient funds do exist for payment of the contract obligations herein.

1. That the contract for Alternate Bid Item 2.0(a) and Alternate Bid Item 2.0(b) be, and hereby is, awarded to Calgon Carbon Corporation subject to all conditions outlined in the Notice to Bidders and Specifications.

2. The Chairman, Executive Director, Secretary and Q.P.A. are authorized to execute any and all necessary documents to implement the intent of this Resolution, upon receipt of signed documents from the low bidder.

3. The Commissioners authorize staff, in consultation with its professionals, to review the bid documentation and determine in their discretion whether to re-bid for the Bid Items listed in the Specifications in which no bids were received.
