WHEREAS, bids were received June 18, 2024 in response to the bid solicitation, by the following bidders:

WHEREAS, both bids contain material defects mandating rejection pursuant to the New Jersey Public Contracts Law, N.J.S.A. 40A:11-1 et seq. and/or substantially exceed the cost estimate/appropriation for the project similarly mandating rejection; and

NOW, THEREFORE, BE IT RESOLVED this 25th day of June, 2024, by the Brick Township Municipal Utilities Authority as follows:

- The Authority rejects the bids submitted for the 2025 Hino Truck Model L6 (258 LP) 25,500 lbs. GVW with Canopy Series Service Body bid.
- 2. The Commissioners authorize staff, in consultation with its professionals to review the bid documentation and determine in their discretion whether to immediately re-bid and/or that the specifications should be substantially revised prior to re-bid.
- 3. The Authority authorizes and directs the Authority Chair, Executive Director and authority Secretary to execute any and all necessary documents in order to implement the intent of this Resolution.
