

## **RESOLUTION NO. 48-24**

### **BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

#### **A RESOLUTION RENEWING ACRISURE LLC DBA IMAC INSURANCE AGENCY AS BROKER OF RECORD AND ACCEPTING THE HORIZON BLUE CROSS BLUE SHIELD RATES PRESENTED BY IMAC AND AUTHORIZING THE HORIZON BLUE CROSS BLUE SHIELD OMNIA PLAN INCENTIVE PROGRAM**

**WHEREAS**, the Brick Township Municipal Utilities Authority (“the Authority”) has appointed Acrisure LLC dba IMAC Insurance Agency as broker of record for the Authority’s Medical and Prescription programs effective on August 1, 2008 by resolution 53 – 08 approved at the May 19, 2008 meeting; and

**WHEREAS**, the Authority also began utilizing Acrisure LLC dba IMAC Insurance Agency as broker of record for the Authority’s Dental Program effective with the April 1, 2010 Delta Dental Renewal; and

**WHEREAS**, the Authority also desires to utilize Acrisure LLC dba IMAC Insurance Agency as broker of record for the Authority’s Long Term Disability and Vision programs effective with subsequent contract renewals; and

**WHEREAS**, the Authority desires to renew the broker of record agreement with Acrisure LLC dba IMAC Insurance Agency the Authority’s medical, prescription, dental, long term disability and vision programs for the period August 1, 2024 to July 31, 2025; and

**WHEREAS**, Acrisure LLC dba IMAC Insurance Agency has prepared a financial analysis of the Authority’s existing medical and prescription programs as well as other competitors and is recommending the Authority to utilize the Horizon Blue Cross Blue Shield Omnia Plan Incentive Program:

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Brick Township Municipal Utilities Authority, County of Ocean, State of New Jersey, as follows:

1. Acrisure LLC dba IMAC Insurance Agency is hereby renewed as broker of record for the Medical, Prescription, Dental, Long-Term Disability, and Vision Programs of the Brick Township Municipal Utilities Authority, commencing August 1, 2024 and continuing through July 31, 2025; and
2. The Brick Township Municipal Utilities Authority authorizes acceptance of the Horizon Blue Cross Blue Shield rates presented by Acrisure LLC dba IMAC Insurance Agency commencing August 1, 2024 and continuing through July 31, 2025, a schedule of said rates is appended hereto; or
3. The Brick Township Municipal Utilities Authority hereby approves the use of the Horizon Blue Cross Blue Shield Omnia Plan Incentive Program.
4. The Brick Township Municipal Utilities Authority authorizes that beginning with medical plan open enrollment changes effective August 1, 2024, employees opting to enroll in the Horizon Blue Cross Blue Shield OMNIA medical plan shall receive a one-time payment of \$1,000.00; and
5. The Authority authorizes and directs the Chief Financial Officer or Executive Director to execute any and all necessary documents in order to implement the intent of this resolution subsequent to the execution of same by Acrisure LLC dba IMAC Insurance Agency and Horizon Blue Cross Blue Shield.
