

**RESOLUTION NO. 70-24**

**BRICK TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

**A Resolution Amending Resolution No. 63-24 for the Award of a Contract for the Purchase of a Peerless Pump, Column Pipe, Pump Head, and Supplemental Parts to Vendor Municipal Maintenance Co. in the Amount of \$133,830 from Account 01-724-008X**

**WHEREAS**, N.J.S.A 40A:-11(5) authorizes contracting units to enter into Cooperative Pricing Agreements for its administration; and

**WHEREAS**, Municipal Maintenance Co. has offered voluntary participation in a Cooperative Pricing System for the procurement of goods and services; and

**WHEREAS**, the Authority seeks to Purchase a Peerless Pump, Column Pipe, Pump Head, and Supplemental Parts; and

**WHEREAS**, the Authority has requested and received a price quote for the purchase of a Peerless Pump, Column Pipe, Pump Head, and Supplemental Parts from Municipal Maintenance Co. in the amount of \$133,830; and

**WHEREAS**, the Authority adopted Resolution 63-24 awarding the contract to vender Municipal Maintenance Co. in the amount of \$130,000.

**WHEREAS**, the correct amount of the price quote was \$133,830.

**WHEREAS**, the Peerless Pump, Column Pipe, Pump Head, and Supplemental Parts will be purchased from vendor Municipal Maintenance Co. through the North Jersey Wastewater Cooperative Pricing System for a total price of \$133,830; and


**WHEREAS**, John Clifford, Chief Financial Officer, has advised the Authority that sufficient funds exist for the payment of \$133,830 is hereby authorized within Capital Budget Account 01-724-008X to fund the purchase of a Peerless Pump, Column Pipe, Pump Head, and Supplemental parts.

**NOW, THEREFORE, BE IT RESOLVED** this 24th day of October, 2024, by the Brick Township Municipal Utilities Authority as follows:

1. The contract for the purchase a Peerless Pump, Column Pipe, Pump Head, and Supplemental Parts is hereby awarded to Municipal Maintenance Co. in the amount of \$133,830.
2. The Chairman and Executive Director and Secretary of the Authority be and hereby are authorized to execute any and all necessary documents in order to implement the intent of this resolution subsequent to the execution of same by Municipal Maintenance Co.
3. Set amount of \$133,830 shall be taken from account 01-724-008X for the payment of the obligation provided for herein.
